- 1) Those licensed (when required) and in good standing with the APIA who serve in related fields such as Attorneys, Information Brokers, Bounty Hunters, Private Process Server and Law Enforcement Officers.
- 2) Members must be of high moral and ethical integrity.
- 3) Associate membership will be given to those gainfully employed as in-house investigators, apprentices, or private investigators living outside Alabama who meet their State and County laws and licensing regulations.
- 4) Student/Intern status shall be awarded to those members who are full time students seeking certification or degrees in criminal justice, corporate security, or related field. Because Students are not licensed Private Investigators; they will not Receive C.E. credits.
